Dr. Neil is a Registered Play Therapist- Supervisor, a Licensed Professional Counselor- Supervisor (LPC-S), a National Certified Counselor (NCC), a National Certified School Counselor (NCSC), an Approved Clinical Supervisor (ACS), and a **Board Certified Telemental Health (BC-TMH) provider**.
